

It is success enacted in the Seventieth Year of the Republic of India as

- 1. (1) This Act may be called the Utar Product: Private Universities Act, 2019.
- (2) It shall extend to whole of the State of Uttar Pradesh.
- (3) It shall come into force on such date as the State Government may, by notification in the Gazette, appoint.

The ACT gives the power to the University to form its Statutes

- (j) make the Statutes, Ordinances and Regulations for the administration and functioning of the University;
- (k) any arrangements made by the University shall not be inconsistent to the provisions of this Act and regulations of the regulatory bodies;
- to ensure transparent functioning of the University and shall put the clearances obtained from the Regulatory Bodies in the public domain;
- (m) furnish information to the State Government as per format and periodicity required by the State Government;
- (n) comply with the norms set up by the State Government for common academic calendar, anti copying measures, admissions, examinations, degrees and certificates etc.;
- (o) the transparent procedure and standard of admissions and fee structure in the University shall be decided and placed in the public domain before the start of the admission process. The last date of admission shall be as per the common academic calendar;

Admission policy of foreign students shall be decided by the Executive. Council of the University and shall be consistent with the standards laid down by the State Government and Regulatory Bodies;

- (p) follow the Common academic calendar as may be prescribed; and
- (q) to undertake to fulfill such other conditions consistent with this Act as may
 be laid down by the State Government before the establishment of the
 University;

23. Correspondence Course/ Distance Education/On Line Courses:

It shall be open to the University to run courses through correspondence/distance education/on line and open study centers for this purpose in conformity with guidelines and norms laid down by the Government and/or the relevant statutory bodies.

24 Establishment of New Centers/Institutions/Schools:

It shall be open to the University to establish new institutions, schools or centers in conformity with statutory guidelines and norms, if any.

25. Provisions relating to women students:

Consistent with the provisions of Article 15(3) of the Constitution of India, it shall be open to the University to make special arrangement in respect of women students, as it may consider desirable.
