

TO WHOM SO EVER IT MAY CONCERN

This is to inform you that as per the Uttar Pradesh Private University's Act 2019 dated 06/08/2019, Swami Vivekanand Subharti University is now governed by the same. Due to its location in Meerut, Uttar Pradesh (Image 1), the ACT gives the power to the University to form its own Statutes by virtue of Article 3 (j) which is quoted herein below:

In pursuance of the provisions of clause (3) of Article 348 of the Constitution, the Governor is pleased to order the publication of the following English translation of the Uttar Pradesh Niji Vishwavidyalaya Adhiniyam, 2019 (Orna Pradesh Adhiniyam Sankhya 12 of 2019) as passed by the Uttar Pradesh Legislature and assented to by the Governor on August 5, 2019. The Uchcha Shiksha Anubhag-1 is administratively concerned with the said Adhiniyam.

THE UTTAR PRADESH PRIVATE UNIVERSITIES ACT, 2015

(U.P. Act no. 12 of 2019)

[As passed by the Uttar Prodesh Legislature]

ACT

to provide for establishment of new Private Universities and incorporation of existing Private Universities in the State of Uttar Frudesh under this Act for imparting higher education and to regulate their functions and for matters connected therewith or incidental thereto.

IT IS HEREBY enacted in the Seventieth Year of the Republic of India as

Short title, extent and continuestation

1. (1) This Act may be called the Uttar Prodesh Private Universities Act, 2019.

(2) It shall extend to whole of the State of Uttar Pradesh.

(3) It shall come into force on such date as the State Government may, by notification in the Gazette, appoint.

"3. Conditions for the establishment of the University. - The sponsoring body shall, for the purposes of establishing the University under this Act, fulfill the following conditions, namely-

(j) make the Statutes, Ordinances and Regulations for the administration and functioning of the University;"


(1) make the Statutes, Ordinances and Regulations for the administration and functioning of the University; (k) any arrangements made by the University shall not be inconsistent to the provisions of this Act and regulations of the regulatory bodies; to ensure transparent functioning of the University and shall put the (1) clearances obtained from the Regulatory Bodies in the public domain. (m) furnish information to the State Government as per format and periodicity required by the State Government; comply with the norms set up by the State Government for common academic calendar, anti copying measures, admissions, examinations, degrees and certificates etc.; the transparent procedure and standard of admissions and fee structure in the University shall be decided and placed in the public domain before the start of the admission process. The last date of admission shall be as per the common academic calendar : Admission policy of foreign students shall be decided by the Executive Council of the University and shall be consistent with the standards laid down by the State Government and Regulatory Bodies; follow the Common academic calendar as may be prescribed; and (p) to undertake to fulfill such other conditions consistent with this Act as may be laid down by the State Government before the establishment of the (q) University; 191 RPH Date 4 Vidhnika Folder (Administra 2019)

Image 2: Formation of Statutes

The Act gives the power to the University to establish Departments for the purpose of spreading education by virtue of Article 11 (n) which is quoted herein below:

"11. Powers of the University. - Subject to the guidelines and norms as prescribed by the Regulatory Bodies and the State Government from time to time the University shall have the powers,-

(n) to establish a faculty, a department, a centre, or school, as the case may be, in accordance with the Act and Statutes;"



- to confer honorary degrees or other distinctions with prior approval of the State Government;
- (f) to institute as per norms of Regulatory Authorities and State Government Directorships, Professorships, Associate Professorships, Assistant Professorships, and other teaching or academic posts required by the University and to make appointments for the same:
- (g) to create administrative, ministerial and other posts and to make appointments thereto;
- (h) to appoint/engage persons of eminence, working in any other University or organization permanently or for a specified period;
- to co-operate, collaborate or associate with any other University or Authority or Institution in India and abroad in such manner and for such purpose as the University may determine;
- to establish and maintain schools, centres, specialized laboratories in other units for research and instructions as are in the opinion of the University, necessary for the furtherance of its objects:
- to institute and award fellowships, scholarships, studentships, medals and prizes;
- to establish, maintain and supervise residences, hostels and promote the health and general welfare Activities for students and staff;
- (m) to make provisions for research and consultancy, and for that purpose to enter into such arrangements with other institutions or bodies as the University may deem necessary;
- (n) to establish a faculty, a department, a centre, or school, as the case may be, in accordance with the Act and Statutes;
- (o) to determine standards in accordance with the State Government and other Regulatory Bodies for admissions into the University, which may include examination, evaluation or any other method of testing to ensure quality;
- (p) to demand and receive payment of fees and other charges;
- (q) to make special arrangements in respect of women and other disadvantaged students as the University may consider desirable;
- to regulate and enforce discipline among the employees and students of the University and take such disciplinary measures in this regards as may be deemed necessary by the University;
- to make arrangements for promoting the health and general welfare of the employees of the University;
- to receive donations and to acquire, hold and manage any property, movable or immovable for the welfare of the University;
- to ensure that no immovable property shall be disposed off or rights or title
 therein parted with or any liability created thereon, by any of the officers
 or authorities of the University, except after prior approval of the State
 Government;
- to appoint either on contract or otherwise, visiting professors emeritus professors, consultants, fellows, scholars, artists, course directors and such other persons who may contribute to the advancement of the objects of the University;
- (w) to organize and to undertake extramural studies and extension service; and
- (x) to do all such other acts and things as may be necessary, incidental or conducive to the attainment of all or any of the objects of the University.

"23. Correspondence Course/ Distance Education/On Line Courses:

It shall be open to the University to run courses through correspondence/distance education/on line and open study centers for this purpose in conformity with guidelines and norms laid down by the Government and/or the relevant statutory bodies."

24 Establishment of New Centers/ Institutions/Schools:

It shall be open to the University to establish new institutions, schools or centers in conformity with statutory guidelines and norms, if any.

25. Provisions relating to women students:

Consistent with the provisions of Article 15(3) of the Constitution of India, it shall be open to the University to make special arrangement in respect of women students, as it may consider desirable.
